# LICENCED LAY MINISTRY & LOCAL MINISTRY CERTIFICATES



#### Welcome and Introduction

"The gifts he gave were that some would be apostles, some prophets, some evangelists, some pastors and teachers, to equip the saints for the work of ministry, for building up the body of Christ, until all of us come to the unity of the faith and of the knowledge of the Son of God, to maturity, to the measure of the full stature of Christ." (Ephesians 4:11-13)

God calls all of us to ministry. Every one of us has a vocation (or 'divine calling') and therefore a contribution to make to ushering in the Kingdom of Heaven. One of the most important things we can do as a Christian community is to help discern that call so that the gifts God has given may be exercised. Once we know what God wants you to do we can then empower you to minister.

Sometimes that empowerment is a simple encouragement to collaborate in the work of the Spirit and to proclaim the Good News. On other occasions particular training, formation, and supervision is required to ensure that the minister is well-prepared, protected, and endorsed.

This set of guidelines is designed to clarify the formal roles and responsibilities available in our Diocese. Specifically it outlines a Ministry Certificate, the three categories of Licenced Lay Ministry, and the Ministry of Anointing with Oil. In addition, it describes some discernment strategies, a selection of preferred training and formation options, and the qualities of a lay minister.

This document is not meant to be a substitute for *The Lay Ministry Licences Statute 2011* (Statute No. 18) but rather a guide for navigating more formal lay ministry. #### ONE: UNDERSTANDING THE LANGUAGE

#### 1.1 What is Ministry?

Ministry is the action of all baptised people who are called to re-present Christ in all aspects of their daily life. In this Diocese we believe that every member of every Ministry Unit has a God-given ministry and it is our hope that these Guidelines empower all to minister more fully in the name of Christ.

Some ministries have been identified as being representative of the Church in a more formal way; these ministries, both lay and ordained, require a <u>Ministry</u> Certificate or a Licence.

A *minister* is literally someone who 'acts upon the authority of another'. Lay and ordained ministers in this Diocese acts under the authority of the Bishop. Therefore a Licenced Lay Minister is someone who has been authorised by the Bishop to exercise a particular responsibility.

#### **MINISTRY CERTIFICATE**

If you are exercising ministry <u>under the direct supervision</u> of someone who already holds a licence from the Bishop you may be eligible for a Ministry Certificate. This certificate is issued by the Vicar on the recommendation of the Vestry to a person who:

- Assists in leading public worship (e.g. a liturgist, intercessor, reader, etc)
- Assists with educational groups and programme (e.g. helps with a home group or Sunday school programme).

#### LICENCED LAY MINISTER

A 'lay' person is someone who is not ordained. A licenced lay minister is someone who has been discerned and trained to exercise ministry on behalf of the church. A lay licence now covers three categories of ministry, and will commence with a practicum year:

- Educator
- Pastor
- · Worship Leader

#### 1.2 What does 'Licenced' mean?

The Bishop issues a lay minister with a licence to recognise and describe the authority delegated by the Bishop. Licensing offers a framework of support for ministry which represents the Church. The Licence indicates that the person's ministry has been discerned by others, that the person has been appropriately equipped, and that the person understands and adheres to the ministry standards

of the Anglican Church in Aotearoa, New Zealand and Polynesia. Anyone who is issued a licence begins a formal relationship with the Diocese. This means that they are accountable to the Church and have made special promises to submit to its authority. In return the Church commits to supporting their ministry.

<u>The Diocese is introducing a Practicum Year from 2025.</u> Before the first Lay Licence is issued, a "provisional licence" will be required to be held for a year, with certain expectations to be met before a Lay Licence will be issued.

Anyone who wishes to receive a licence will need to receive a clear Police Check, processed through the Diocese, and will need to undergo a full background screening clearance. The cost of the screening will be passed on to the Parish/Ministry Unit by the Diocese.

### 1.3 Who can become a Licenced Lay Minister (LLM)?

In order to be eligible to become an LLM you must be:

- · Baptised;
- A regular member of an Anglican ministry unit (e.g. a Parish, Mission Unit, School or Social agency);
- Supported by the community you belong to and the body that leads them (e.g. be nominated by people in the congregation and receive the support of Vestry);
- · Appropriately prepared;
- · Willing to sign declarations;
- · Willing to undergo police check and background screening processes; and
- Willing to attend local and diocesan training as appropriate.
- Complete the Practicum year and be confirmed as ready for a full Licence.

#### TWO: WHAT ARE THE OPTIONS?

## 2.1 Ministry Certificate

As mentioned above, a Certificate is perfect for anyone whose ministry is supervised by a licence holder. It is not necessary to have a certificate to exercise ministry under supervision but it does invite intentional support and might be used as a stepping stone toward a lay licence. The Certificate is issued by the Vicar at the Vestry's request and the recipient must sign two declarations before receiving it (see "Declarations", next page). Anyone with a Certificate would be expected to attend parish training sessions relevant to the ministry exercised. Ministry Certificate holders are also welcome to attend regional or diocesan training events relevant to their ministry.

A Certificate is valid for three years at a time and may be renewed or cancelled by the Vicar at his/her discretion. Only those baptised and on the Parish Roll are entitled to receive and retain a Certificate. Please refer to the Administration page, Ministry Resources, on the website for the template.

### 2.2 Types of Licenced Lay Ministry

In this Diocese a Lay Licence authorises the recipient to exercise three categories of ministry:

**Worship Leader:** For those who plan and lead such public worship services as are from time to time approved and who may conduct funerals. They may distribute extended communion as requested by the Bishop, their Vicar or Vicar's nominee.

**Pastor:** For those who undertake the pastoral and social work of the parish including caring for the pastoral needs of the faith community, such as visiting, and administering extended communion in the name of the local Ministry Unit.

**Educator:** For those who are responsible for responding to the educational needs of the local Ministry Unit. This includes working with children and youth, leading Bible Studies and preaching more than twice per year.

A Ministry of Healing licence may also be granted for those who exercise the ministry of healing through the laying on of hands and/or anointing with Oil.

#### **DECLARATIONS**

Anyone seeking a Ministry Certificate or a Lay Licence <u>must sign two declarations</u>. **The first** confirms your willingness to accept the authority of General Synod. **The second** confirms your willingness to accept the authority of the Bishop and adhere to the stand or ethics described in Title D Canon 1 Part A. (Both declarations are included in the Appendicies).

## 2.3 Ministry of Healing Licence

At the discretion of the Bishop a lay person may be licenced to exercise the Lay Ministry Office of Minister to Anoint with Consecrated Oil. Any person who wishes to be considered for this special permission must be:

- Nominated by the Vicar and the Churchwardens and approved by the Vestry;
- Trained to anoint with oil by the Bishop or the Bishop's appointee;
- · A member of the Ministry Team;
- Subject to a covenant; and
- Willing to sign the declarations that acknowledge the authority of General Synod and obedience to the Bishop.

#### 2.4 Expectations of an LLM

- Each Licenced Lay Minister is required to meet with an external supervisor or spiritual director at least four times per calendar year. These sessions may be conducted in a group environment.
- Every LLM must have a covenant which outlines his/her role and responsibilities.
- · An LLM is a Christian role model.

#### THREE: THE QUALITIES OF A LICENCED LAY MINISTER

"But we appeal to you, brothers and sisters, to respect those who labor among you, and have charge of you in the Lord and admonish you; esteem them very highly in love because of their work. Be at peace among yourselves. And we urge you, beloved, to admonish the idlers, encourage the fainthearted, help the weak, be patient with all of them. See that none of you repays evil for evil, but always seek to do good to one another and to all. Rejoice always, pray without ceasing, give thanks in all circumstances; for this is the will of God in Christ Jesus for you. Do not quench the Spirit. Do not despise the words of prophets, but test everything; hold fast to what is good; abstain from every form of evil." (1 Thess 5:12-22 NRSV)

A person who is a Licenced Lay Minister should:

#### Be spiritually mature:

- Be regular in prayer and theological reflection
- Be able to articulate and speak about their relationship with God
- Be able to help others recognise God in their lives
- Have a sense of vocation to the ministry of a Licenced Lay Minister.

#### Have these personal qualities:

- Compassion
- Trustworthiness
- Honesty
- Integrity
- A love for others, irrespective of difference
- Listening skills
- Patience
- Inclusiveness
- Confidentiality
- Willingness to learn and to make changes
- Sense of humour.

#### Be willing to develop in the areas of:

- Being part of a ministry support team and to be committed to attending team meetings.
- Being able to work alone.
- Being committed to training and formation.
- Being committed to growing in their self-awareness (acknowledging their strengths and weaknesses).
- Being open to change both personal change and in the life of the Parish.

#### **FOUR: DISCERNMENT**

#### 4.1 What is discernment?

The New Testament encourages us to examine everything and work out whether it is good (from God) or bad (and therefore something to avoid): 1 Thess 5:21-22.

The same can be said when trying to work out your vocation (or calling): some roles are right for us and some are not.

Discernment can be worked out just between you and God for some things, but in a ministry setting it is best to work with a process to help you discover what God might be saying.

#### 4.2 How might discernment work?

#### Here are two ways it might happen.

#### **Organic Discernment**

Organic discernment takes place when a ministry unit observes one of its members exercising particular gifts or qualities, and chooses to engage with her/him. In this instance an exploratory conversation is held between the person and an appropriate representative (LLM, clergy person) to discover what kind of ministry the candidate feels called to.

#### Strategic Discernment

The parish may form a Discernment Group to convene when necessary to prayerfully consider the gifts needed to maintain a healthy, vibrant ministry team. The discernment group may be made of up to eight people, including two of each of the following groups:

- Ministry team
- Vestry
- Congregation
- Parish clergy

(The Vicar would normally convene the group)

The role of the discernment group is two-fold:

- 1. To prayerfully identify the gifts that are needed in the ministry team; and
- 2. To identify people in the parish who have those particular gifts.

The discernment group offer names to the Minister in Charge and vestry for their consideration.

The Minister in Charge is to ensure that the person understands the content of this booklet.

#### Consultation

Whatever form discernment take, the Minister in Charge speaks with members of the Ministry Team, Wardens and members of the congregation who would act as nominators, about the person. If there is support for the person they will be invited to continue with the process. The Vestry is required to pass a motion of support for the application to proceed.

The Minister in Charge and the person to be licenced negotiate a Ministry Covenant to ensure expectations and understanding of ministry, training and accountability are clear.

The Minister in Charge, Vestry and the person fill in the Nomination of a Candidate for a Licence as a Lay Minister. The person signs the Declaration of Acknowledgment of the Authority of General Synod Te Hīnota Whānui and the Synod of Waikato & Taranaki. These are sent to the Bishop's Executive Chaplain. Once all of the requirements set out in 1.3 are met, the Bishop will then make a decision about whether the licence is issued or if additional information is required.

When a person who is licenced as a Lay Minister moves to another parish, the parish to which the person moves uses this process in full to apply for a new licence. The current Minister in Charge may consult with the former Minister in Charge about the person.

#### FIVE: EDUCATION FOR LICENCED LAY MINISTERS

The need for education and training for ministry should be explained to candidates when they are exploring licenced lay ministry. The Minister in Charge will negotiate with the person to be licenced about specific training needs.

**The Practicum Year** provides intentional learning and development opportunities around three core modules. Each module has three sessions, one face to face and two on-line. Each module has an assignment that has to be completed within the 12-month period from the start of your practicum year. i.e. three assignments. The three core modules are:

- An introduction to Anglican Identity throughout history and in these Islands
- An introduction to Anglican Worship, Liturgy and doctrine
- An introduction to Pastoral Practice.

Further information regarding the Practicum Year can be obtained from the Bishop's Executive Chaplain.

Each licenced lay minister covenants to participate in regular ministry support team meetings and Diocesan Licenced Lay Ministry training events (please refer to <u>our website</u> for information of events coming soon!). This includes attending a Boundaries / Title D course every three years. Each licenced lay minister is provided with a copy of the *Diocesan Licenced Lay Ministry Information and Formation Manual* which is currently being revised but will be able to be used as a training resource.

#### **Programmes and Funding**

The cost of study will generally be carried by the Licenced Lay Minister. However the parish may offer to contribute towards the cost after negotiation. There are also some subsidies available from the Diocese. These subsidies may apply to specific training courses, or to long term study when funds are available.
